PURPOSE:

To inform Council of an application received to requesting permission to remove a grid.

CONTENT:

Council recently received an application from Radha Blacket of Alderley Pastoral Company (APC) seeking approval to remove the Boulia Township/Hartnell Downs grid located on the Diamantina Development Road 93E, chainage 4.99 (approximately 4 km out of the Boulia township heading towards Mt Isa). The proposal received is as follows:

Our proposal is to fence the Diamantina Development Road through Hartnell Downs which would allow for the removal of the town grid if Council is in agreement. If in agreement, I will forward your response on to Dept Main Roads.

The grid is an asset held by the Department of Transport and Main Roads (TMR), therefore the overarching decision as to whether or not the grid is able to be removed, who will bear the costs etc. will be made by TMR. Council's approval/objection on the request will be a supporting factor to APC's application to TMR.

An assessment of the request presents no reasons why the grid should not be removed, therefore it is recommended that Council advise Alderley Pastoral Company that Council has no objection to the grid's removal.
