# 1.6 Revenue Statement

## 1.6.1 Revenue Statement 2023-2024

### **PURPOSE:**

This Revenue Statement is based on the principles set out in Council's Revenue Policy and has been formulated in accordance with section 172 of the Local Government Regulation 2012.

- 1. That in accordance with Section 169(2)(b) of the Local Government Regulation 2012, the 2023/2024 Boulia Shire Revenue Statement be hereby adopted.
- 2. That in accordance with section 81 of the Local Government Regulation 2012, the categories into which rateable land is categorised, and the description of those categories for the 2023/2024 financial year be as set out in the first table appearing in Council's Revenue Statement 2023/2024.

- 3. That in accordance with section 257 of the Local Government Act 2009, Council delegates to the Chief Executive Officer the power, contained in subsections (4) and (5) of section 81 of the Local Government Regulation 2012, to identify the rating category towhich each parcel of rateable land belongs.
- 4. That in accordance with section 94 of the Local Government Act 2009 and sections 80 and 77 of the Local Government Regulation 2012, the differential general rates, and minimum general rates, for the 2023/2024 financial year be as set out in the first table appearing in Council's Revenue Statement 2023/2024.
- 5. That in accordance with section 94 of the Local Government Act 2009 and section 99 of the Local Government Regulation 2012, Council resolves to levy a cleansing utility charges, as further detailed in Council's Revenue Statement 2023/2024.

The cleansing utility charges shall be:

- \$379.00 per annum for Residential occupied premises (collected once per week)
- \$195.00 per annum for Additional Bin service at Residential occupied premises (collected once per week)
- \$1,227.00 per annum for Commercial Bin Service (collected three times per week 2 bins)

Where a service is provided for only part of the year cleansing charges will be levied on a pro rata time basis.

Charges for the collection of industrial and bulk waste will be based on type of waste, volume and frequency of collection. Charges will be determined on a cost recovery basis as required.

6. That in accordance with section 94 of the Local Government Act 2009 and section 99 of the Local Government Regulation 2012, Council resolves to levy a waste management utility charge, as further detailed in Council's Revenue Statement 2023/2024.

The waste management utility charge shall be:

- \$90.00 per annum for all unoccupied / vacant land in townships and all rural properties within a 30 kilometres radius of the townships of Boulia and Urandangi.
- 7. That in accordance with section 94 of the Local Government Act 2009 and section 99 of the Local Government Regulation 2012 sewerage utility charges for the 2023/2024 year are made and will be levied for the purposes of providing for the removal of refuse from all occupied premises (domestic and commercial), as further detailed in Council's Revenue Statement 2023/2024.
  - The sewerage utility charge (connected) shall be \$482.00 per annum.
  - The sewerage utility charge (not connected) shall be \$194.00 per annum.
  - Commercial properties shall be charged based on a comparison to a standard house block, dependant on its size, use and impact on these services.
- 8. That in accordance with section 94 of the Local Government Act 2009 and section 99 of the Local Government Regulation 2012, Boulia Shire Council hereby levies Water Utility Charges for the Financial Year 2023/2024, as further detailed in Council's Revenue Statement 2023/2024.
  - The water utility charge shall be \$683.00 per annum.
  - The vacant land water utility charge shall be \$493.00 per annum.
  - Commercial properties shall be charged based on a comparison to a standard house block, dependant on its size, use and impact on these services.

9. That in accordance with section 94 of the Local Government Act 2009 and section 103 of the Local Government Regulation 2012, Council resolves to levy an environmental separate charge, as further detailed in Council's Revenue Statement 2023/2024.

The environmental separate charge shall be:

- \$50.00 per annum for all properties in the Boulia Shire.
- 10. That in accordance with section 107 of the Local Government Regulation 2012 and section 114 of the Fire and Emergency Services Act 1990, Council's rates and charges, and the State Government's Emergency Management, Fire and Rescue Levy be levied:
  - for half year 1 July 2023 to 31 December 2023 in August/September 2023;
    and
  - for the half year 1 January 2024 to 30 June 2024 in February/March 2024.

Pursuant to section 118 of the Local Government Regulation 2012, that Council's rates and charges, and the State Government's Emergency Management, Fire and Rescue Levy, be paid within 30 clear days of the date of the issue of the rate notice.

- 11. That in accordance with section 133 of the Local Government Regulation 2012 a charge of 11.64 percent compounding interest calculated on daily rests be hereby made and levied on rates and charges that are 30 days overdue starting on 1st July 2023.
- 12. That in accordance with section 130 of the Local Government Regulation 2012 a discount of 4% be allowed for all current Council rates & charges (excluding fire levy) if paid within 30 days of issue, and that such discount be calculated as a percentage of the gross rate/charges levied, and only be granted if all current and outstanding rates have been paid in full.
- 13. That in accordance with sections 121 & 122 of the Local Government Regulation 2012 Council will not charge general rates to pensioners who reside in their own premises within the townships of Boulia and Urandangi provided there are no outstanding rates from previous periods.
- 14. Council offers a **30% subsidy** on all **services** (excepting the fire levy) to pensioners who reside in their own premises within the townships of Boulia and Urandangi. This subsidy is in addition to the 20% subsidy offered by the State Government with both subsidies capped at \$180.00 per annum, each.

**Utility Charges:** 

Cleansing:

In accordance with s99 Local Government Regulations 2012, Council resolves to levy a commercial waste collection and disposal charge according to Council's Revenue Statement 2023/2024.

The cleansing charges shall be:

\$379.00 per annum for Residential occupied premises (collected once per week) \$195.00 per annum for Additional Bin service at Residential occupied premises (collected once per week)

\$1,227.00 per annum for Commercial Bin Service (collected three times per week 2 bins)

Where a service is provided for only part of the year cleansing charges will be levied on a pro rata time basis.

Charges for the collection of industrial and bulk waste will be based on type of waste, volume and frequency of collection. Charges will be determined on a cost recovery basis as required.

**Waste Management Facility**

The waste management facility charge shall be: \$90.00 per annum for all unoccupied / vacant land in townships and all rural properties within a 30 kilometres radius of the townships of Boulia and Urandangi.

\$50.00 per annum for all properties in the Boulia Shire.

Sewerage:

That in accordance with s94 of the Local Government Act 2009 and s99 Local Government Regulations 2012 cleansing charges for the 2023/2024 year are made and will be levied for the purposes of providing for the removal of refuse from all occupied premises (domestic and commercial) according to Council's Revenue Statement 2023/2024.

The residential house block sewerage charge shall be \$482.00 per annum.

The vacant land sewerage charge shall be \$194.00 per annum.

Commercial properties shall be charged based on a comparison to a standard house block, dependant on its size, use and impact on these services.

**Boulia and Urandangi Water Schemes:**

The residential house blocks water service charge shall be \$683.00 per annum.

The vacant land water service charge shall be \$493.00 per annum.

Commercial properties shall be charged based on a comparison to a standard house block, dependant on its size, use and impact on these services.

That in accordance with s130 of the Local Government Regulation 2012 a discount of 4% be allowed for all current Council residential rates & charges (excluding fire levy) if paid within 30 days of issue, and that such discount be calculated as a percentage of the gross rate/charges levied, and only be granted if all current and outstanding rates have been paid in full for the 2023/2024 year.

**Council Pensioner Rate Remission:**

This subsidy is in addition to the 20% subsidy offered by the State Government with both subsidies capped at \$180.00 per annum each.
